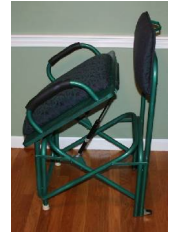


PORTABLE LIFT CHAIRS LLC DELUXE FRANCHISE CONTRACT AGREEMENT



INTRODUCTION:

A franchise is a right granted to an individual or group to market a company's goods or services within a certain territory or location. Some examples of today's popular franchises are McDonald's, Subway, Domino's Pizza, and the UPS Store.

There are many different types of franchises. For the most part many people associate only fast food businesses with franchising. Where In fact, there are over 120 different types of franchise businesses available today, including automotive, cleaning & maintenance, health & fitness, financial services, and pet-related franchises, just to name a few.

If you are thinking about buying into any franchise system:

It is important that you understand exactly how franchising works:

An individual who purchases and runs a franchise is called a "**franchisee**." The franchisee purchases a franchise from the "**franchisor**." The franchisee must follow certain rules and guidelines already established by the franchisor:

- h, You agree/to and understand that **Portable Lift Chairs LLC** - is giving you the opportunity to become a successful FRANCHISEE and you realize that in order to get your initial investment back you will need to start selling our products once you receive your franchise kit from us

What is your Up-front, one-time franchise fee to the franchisor?

Your Up-front, one-time franchise fee is **one thousand and ninety-eight dollars (\$1,098.00)**

What does your franchise fee payment give you?

There are no additional fees for your franchise purchase

Our Comfy Product line allows you to make 85% total gross profit - per sale on all items

Our Portable chairs product line allows you to make 20% total gross profit - per sale on all items

Are there any other additional requirements?

- b, You are not required to pay any monthly or annual maintenance fees
- c, You are not required to have any overhead expenses - being you work for yourself
- d, You are not required to take any training courses - the videos demonstrate the products
- e, You are not required to pay any consulting fees - our franchise is show & tell and sell
